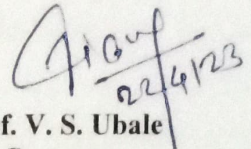

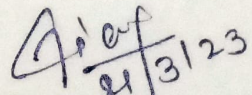
Following members were present for the meeting;
