


Report of Anti-Ragging Committee on the Incident Reported on Tuesday,

Following are the minutes and findings of the meeting.

1. Complainant and opponent, both are studying in final year of civil and electronics engineering. As both are studying in same year but in different branches, both are the senior students.
2. Both the involved girls are staying in hostel (Room No 125 and Room No 123).
3. As per the enquiry done by anti-ragging committee and statements by both involved, it is understood that the incident happened due to mere misunderstanding and personal problems/issues.
4. As only two girls are involved in this case, there is no instance of harassing by a group of students to the Complainant or by senior to junior.
5. As per the statements of both the girls involved and investigation of eye witnesses, there was exchange of hot words between them. No abusive words or physical harassment was identified by Anti ragging committee.
6. In the counseling, the Complainant agreed that, she has directly approached to antiragging help line, before contacting to the concerned authorities of the institute.
7. In the anti-ragging counseling sessions, both the girls involved in the incident unanimously agreed that this incident is merely due to personal misunderstanding and issues.
8. The Complainant was counseled and assured by the authorities about her safety.
9. Both the girls are convinced and the issue is resolved with mutual respect and greetings.
