Instructions:

1. Three merit lists based on MH-CET Percentile (MS Candidature), JEE (Main) Score (All India Candidature) and Institute Level will be published on Amrutvahini College of Engineering, Sangamner website as per the schedule.

2. Institutional quota seats will be filled based on MH-CET, with preference to Maharashtra State candidates over All India candidates. ACAP seats will be filled within the same category as vacant in CAP rounds.

3. Candidates listed (or parent) in the merit lists must be physically present at the college on 10-9-2025 as per above schedule for the SPOT Round. Candidates should bring required documents and pay Rs. 1000/- application process fee. (Non-refundable and non-transferable)

4. Seats will be offered based on merit and availability. Upon acceptance, candidates must submit documents and pay fees on the spot to confirm admission. Non-acceptance requires submitting a letter immediately.

General Instructions:

1. The detailed schedule about the round execution will be uploaded on the Institute's website as per the guidelines and notification of the State CET Cell and all the other competent authorities in due course of time.
2. The schedule of Admission is provisional, and dates are subject to change as per the guidelines of the competent authorities.
3. The updated schedule, if any, shall be uploaded to the Institute's website from time to time.
4. The candidates must read all the following instructions carefully before applying for this round.
5. Admission process will be conducted as per rules and regulations published in the information brochure by State CET Cell for AY 2025 – 26 (for details refer to www.mahacet.org).
6. Admissions shall be made in a transparent manner after the CAP Rounds and strictly as per the *Inter-Se-Merit* of the candidates who have applied to the Competent Authority for verification of documents and then applied explicitly on Amrutvahini College of Engineering, Sangamner
7. ACAP seats shall be allotted to candidates belonging to the same category for which they were originally designated during the CAP process. If any seats remain unfilled, they will subsequently be offered based on the Inter-Se-Merit of the remaining applicants.
8. All Candidates admitted through this round shall pay the fees as prescribed by the Fees Regulating Authority for Unaided Private Professional Educational Institutions for AY 2025-26, Govt. of Maharashtra, S.P.P.U. and all competent authorities.
9. Dynamic Vacancies created due to cancellation during the admission round, will be filled in the same round.
